

銘傳大學教師暨研究人員學術研究倫理教育課程實施要點

- 一、為培養本校教師暨參與國科會計畫之研究人員瞭解學術倫理相關規範，精進學術研究之品質，特訂定「銘傳大學教師暨研究人員學術研究倫理教育課程實施要點」。
- 二、本要點實施對象為本校專任(案)教師、首次參與國科會計畫之專兼任研究助理、臨時工等計畫內所有研究人員。
- 三、新進教師應於到職 1 年內取得至少 6 小時學術倫理教育課程研習證明，本要點實施前已在職之教師，應於 108 年 7 月 31 日前取得至少 6 小時學術倫理教育課程研習證明；若為國科會計畫執行後所聘首次參與之研究人員，應於起聘日起 3 個月內繳交 6 小時學術倫理教育課程研習證明。
前述人員須選擇以下課程修習：
 - (一)「臺灣學術倫理教育資源中心」網站 (<https://ethics.moe.edu.tw/>) 之學術倫理相關課程。
 - (二)各校辦理學術倫理研習課程。
 - (三)各學院、系所、通識教育中心及行政單位辦理學術倫理研習課程。前項課程由主辦單位核發講習證明，並將講習證明繳交研發處備查。
- 四、本要點經行政會議通過後實施，修正時亦同。

Ming Chuan University Procedures for Academic Research Ethics Education Course Conducted for Faculty Members and Research Fellows

1. The Procedures for Academic Research Ethics Education Course Conducted for Faculty Members and Research Fellows is established for MCU faculty members and research fellows who participate in **National Science and Technology Council (NSTC)** projects to let them better understand the related regulations of academic research ethics.
2. These procedures are applied to full-time and special program MCU faculty members and research fellows including full-time and part-time research assistants, and temporary workers when they apply for **NSTC** project grants for the first time.
3. New faculty members should acquire the credit verification of completing at least 6 hours of Academic Research Ethics Education Course within one year after reporting for duty. Current faculty members who were appointed before the implementation of these Procedures should acquire the credit verification of completing at least 6 hours of Academic Research Ethics Education Course prior to July 31, 2019; Research fellow who were first employed by the university during a **NSTC** research project period should submit their course credits verification of completing 6 hours of Academic Research Ethics Education Course within 3 months of the date of employment.

Abovementioned personnel should select from among the following courses:

- a. Academic Research Ethics related courses on Center for Taiwan Academic Research Ethics Education Website (<https://ethics.moe.edu.tw/>)
- b. Academic Research Ethics related training courses offered by other universities.
- c. Academic Research Ethics related training courses offered by colleges, departments, General Education Centers, or administrative units in universities.

All the verification will be issued by the course organizer, as mentioned above, and applicants should submit their verification to Research and Development Division as reference.

4. Upon being passed at the Administrative Council Meeting, these procedures were implemented. Any revision must follow the same procedure.

In the event of any inconsistency or discrepancy between the Chinese and other language versions of this document, the Chinese version shall prevail.
